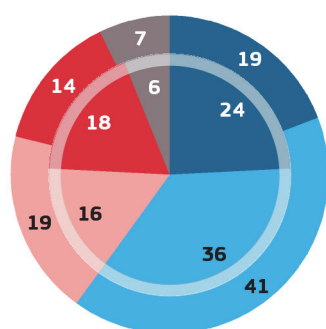

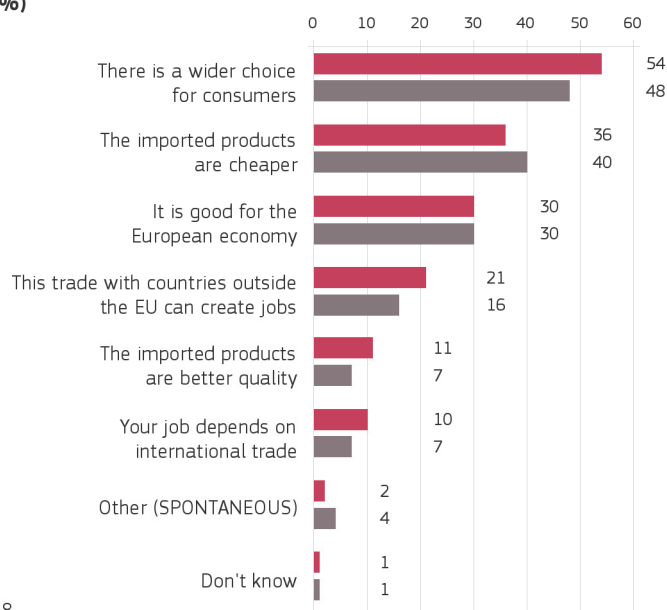

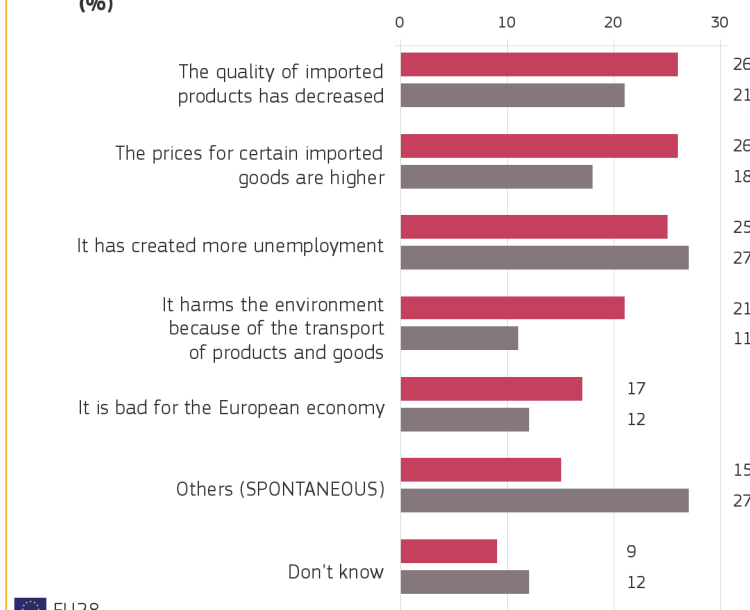

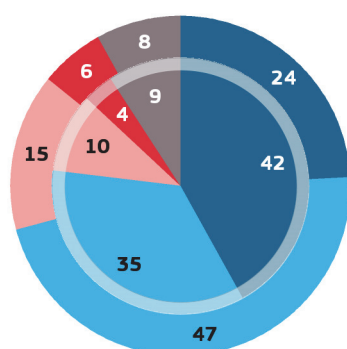

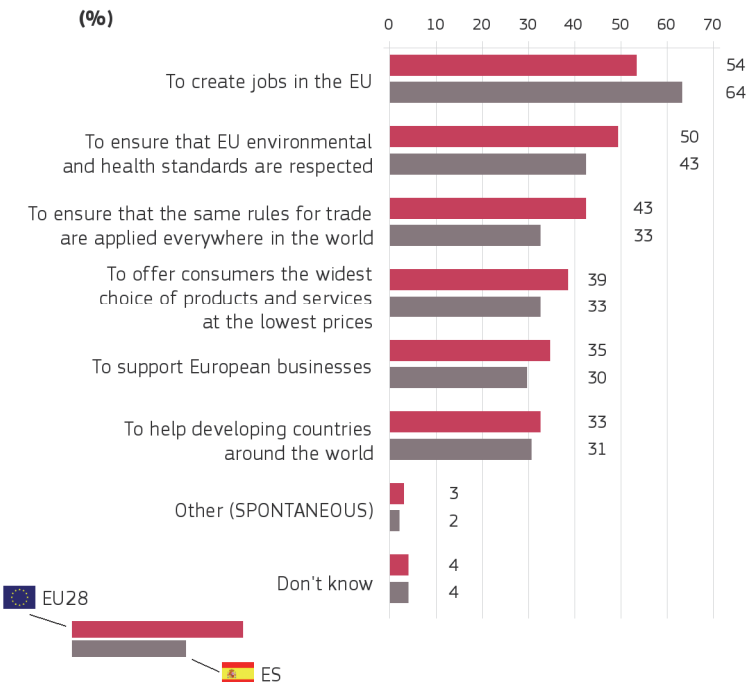

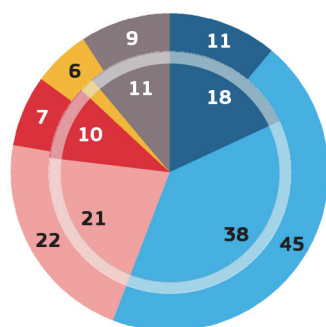

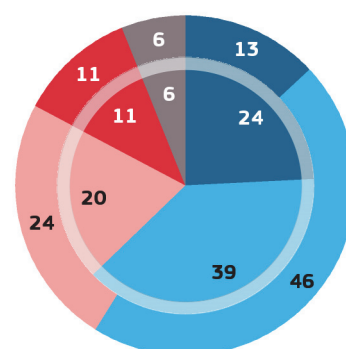

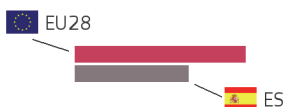
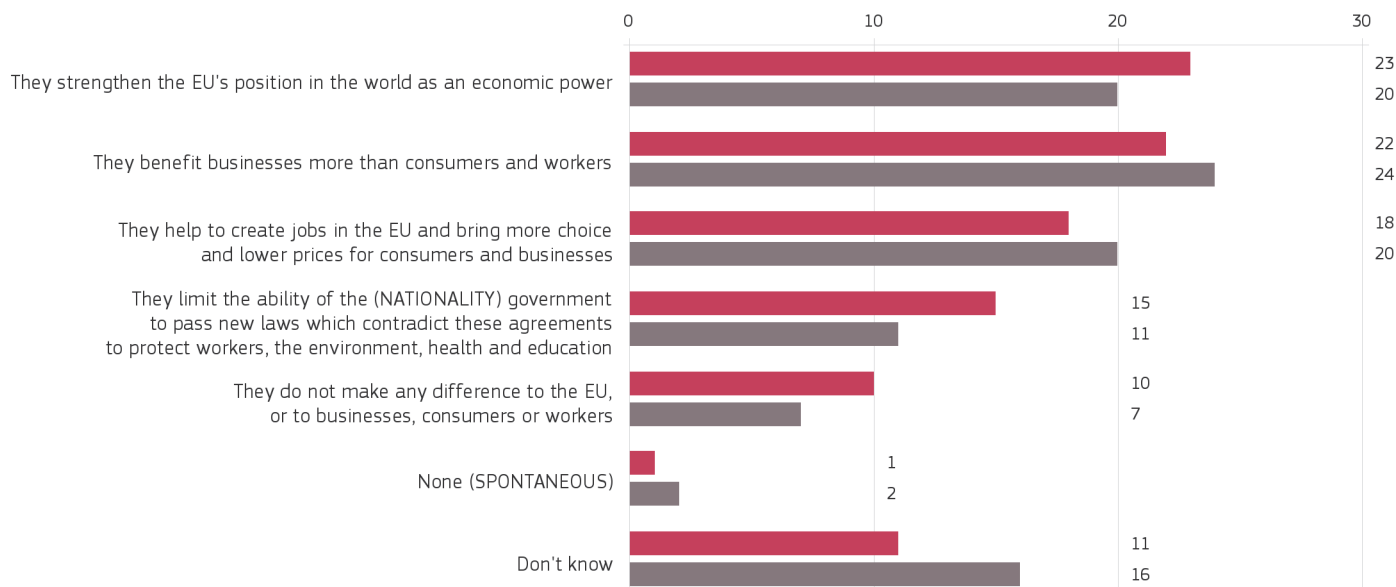

QA13 The EU has signed trade agreements with countries including Canada, Japan and Mexico. Which of the following statements about the EU's trade agreements do you agree with most?

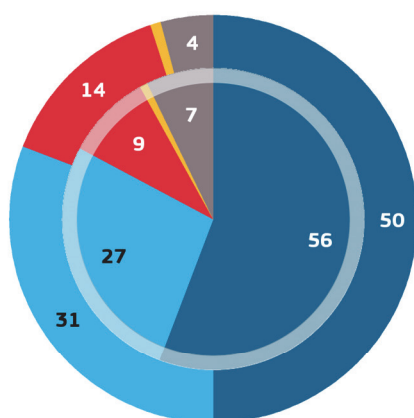

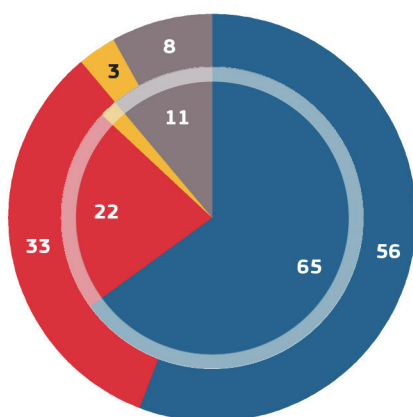

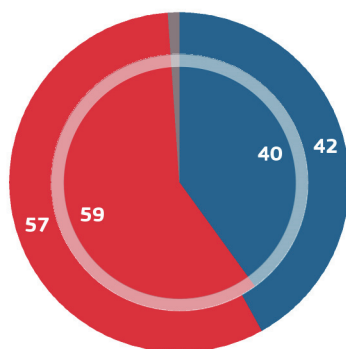

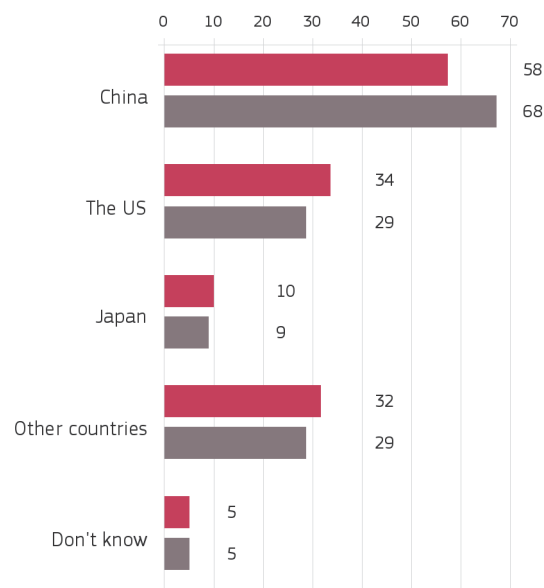
